<p style="text-align: center;">Terms and Conditions of the CKM SYTS Membership for Natural Persons According to the Association's Statutes</p> <p><u>Membership of the Association</u></p> <p>1.1/ CKM SYTS is a voluntary association and none of its Members may be stripped of their rights. This rule is considered to be the basic principle of the CKM SYTS's activity.</p> <p><u>Start of the membership</u></p> <p>2.1/ As Members of the Association may become:</p> <ol style="list-style-type: none"> 1. Natural persons 2. Natural persons - full-time students 3. Natural persons - full-time and part-time teachers according to 2.1.3. <p>2.1.1/ A natural person becomes a Member of the Association by completing a membership application - a registration sheet and by paying a membership fee specified for natural persons and, in the case of further membership of the Association, by updating data in the membership application - registration sheet and by paying a membership fee for natural persons, while he/she proves his/her membership by a Membership Card.</p> <p>2.1.2/ A full-time student becomes a Member of the Association by submitting a valid document that confirms that he/she is a full-time student at an institution accredited by the Slovak Ministry of Education in the respective academic year and by paying a yearly membership fee, while he/she proves his/her membership with his/her membership card.</p> <p>2.1.3/ A teacher becomes a Member of the Association by submitting a valid document that proves that he/she is a teacher employed by an institution accredited by the Slovak Ministry of Education in the respective academic year, with the weekly working time of at least 18 hours (or 10 hours a week, if he/she is not in any other employment concerning teaching) and by paying a yearly membership fee, while he/she proves his/her membership with his/her Membership Card.</p> <p>2.2/ The yearly membership fees for the persons specified in point 2.1.1 - 3/, together with the limitation of the lasting of the membership separately for each type of Member, is specified by the CKM SYTS's Board of Directors on a yearly basis.</p> <p><u>Termination of the membership</u></p> <p>3.1/ The membership of the persons in the Association according to provisions 3.2.1 - 3/ is terminated:-</p> <ol style="list-style-type: none"> a) by the termination of the CKM SYTS's activities; b) by the Member's written notice and simultaneous return of his/her Membership Card; c) by expelling the Member due to his/her breaching of the CKM SYTS Statutes on the basis of a decision of the CKM SYTS's Board of Directors; d) by the Member's death; e) by the expiry of the Membership Card's validity. <p><u>Membership Cards</u></p> <p>4.1/ CKM SYTS annually issues and distributes the following Membership Cards:</p> <ol style="list-style-type: none"> a) IYHF (International Youth Hostels Federation) Card for natural persons without age limitation; b) ISIC (International Student Identity Card) for full-time students; c) ITIC (International Teacher Identity Card) for teachers according to the provisions of 2.1.3/; d) EURO-26 Youth Card for natural persons aged 26 years or less; e) GO-26 Youth Card for natural persons aged 26 years or less; <p>4.2/ Among other details, the Membership Card contains the Association Member's - Card Holder's - name and the Card's expiry date.</p> <p>4.3/ Membership Cards are distributed through the members and associated members of CKM SYTS, as well as through third parties, in the whole territory of Slovakia. After receiving a Membership Card and paying a membership fee, each CKM SYTS Member will receive a free copy of an Information Guide along with the respective Card, which contains information about discounts, advantages, and possibilities of the use of the Card in Slovakia and abroad, together with the promotion of individual subjects offering such discounts and services usable by the Card's holder.</p> <p>4.4/ Several times a year, CKM SYTS issues information brochures and other information and promotional materials containing changes in the discount provision system, short-term occasional discounts and other up-to-date information, adding to or notifying about newly created opportunities for the realization and development of the Association Members' needs.</p> <p><u>Rights and obligations of the Association Members</u></p> <p>5.1/ After showing his/her Card, a Member of the Association according to provisions 2.1.1 - 3/ is entitled to use all advantages and discounts specified in the Information Guide, particularly to:-</p> <ol style="list-style-type: none"> a) Use discounts and advantages in transport, accommodation, travel, and culture; b) Be a participant of organized meetings and other CKM SYTS's activities; c) Regularly receive information concerning opportunities to use CKM SYTS Membership Cards at home and abroad. <p>5.2/ A Member of the Association according to provisions 2.1.1 - 3/ is obliged to observe the Association's Statutes, and, no later than upon receiving a Membership Card, to pay the due Membership Fee specified by CKM SYTS's Board of Directors.</p> <p>5.3/ When using individual advantages and discounts, a Member of the Association according to provisions 2.1.1 - 3/ is obliged to show his/her Membership Card, and, if requested by a discount provider, to show another personal identification card.</p> <p><u>Loss of the CARD</u></p> <p>6.1/ A duplicate of the card (this only concerns non-chip cards) is issued by the CKM SYTS Association on the basis of a Member's request in writing for a €3.30 fee.
