The Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as "STU") in accordance with Section 92 par. 15 of the Act No. 131/2002 Coll. on Universities and on the Amendment and Supplements to Certain Acts, as amended and in line with Article 9 (2) of the Rector's Directive No. 8/2014-SR Tuition and Fees Related with Studies at the Slovak University of Technology in Bratislava for the Academic Year 2015/2016 of 10 September 2014, as amended by Amendment No. 1 of 4 March 2015 and Amendment No. 2 of 16 February 2016 issues this

as amended by Amendment No. 1 of 4 March 2015 and Amendment No. 2 of 16 February 2016  
(hereinafter referred to as "Amendment No. 3")

**Article I.**

The Rector's Directive No. 8/2014-SR of 10 September 2014 on Tuition and Fees Related to Studies at the Slovak University of Technology in Bratislava for the Academic Year 2015-2016, as amended by Amendment No. 1 of 4 March 2015 and Amendment No. 2 of 16 February 2016 (hereinafter referred to as the "Rector's Directive"), shall be amended as follows:

1. In Article 7 (1), after the words "acknowledging the equivalence of documents about studies" shall be inserted the words "under a special Regulation,".
2. The footnote to reference 18 shall be read as follows:  
„<sup>18</sup> Section 33 to 35 of the Act No. 422/2015 Coll. Recognition of Diplomas and Professional Qualifications and on amendments to certain laws”.
3. In Article 7 (3), letter d) reads as follows:  
„d) the administrative fee for recognition of diplomas<sup>18</sup> € 6,50”.
4. In Article 7 (3) are introduced after the letter d) new letters e) and f), which shall read as follows:  
„e) payment of costs connected with proceedings for recognition of diplomas<sup>18</sup> € 40  
f) payment of costs connected with proceedings for automatic recognition of diplomas<sup>18a</sup> € 20”.
5. The footnote to reference 18a shall read as follows:  
„<sup>18a</sup> Section 39 of the Act No. 422/2015 Coll. Recognition of Diplomas and Professional Qualifications and on amendments to certain laws”.
6. After Article 8 is introduced a new Article 8a, including the title reads as follows:

„Article 8a

**Transitory provisions effective as of 7 June 2016**

Administrative fees for recognition of diplomas paid during the period from 1 January 2016<sup>21a</sup> until the entry into force of Amendment No. 3 to this Directive are considered administrative fees for recognition of diplomas under this Directive.”.

7. The footnote to reference 21a shall read as follows:

„<sup>21a</sup> The effectiveness of the Act No. 422/2015 Coll. Recognition of Diplomas and Professional Qualifications and on amendments to certain laws”.

## **Article II.**

1. Other provisions of the Rector’s Directive shall remain unchanged.
2. Amendment No. 3 shall form an inseparable part of the Rector’s Directive.
3. Amendment No. 3 has an inseparable part Annex No. 1 containing “The complete wording of the Rector’s Directive No. 8/2014-SR of 10 September 2014 - Tuition and Fees Related to Studies at the Slovak University of Technology in Bratislava for the Academic Year 2015-2016 - as amended by Amendment No. 1 of 4 March 2015 , Amendment No. 2 of 16 February 2016 and Amendment No. 3 of 7 June 2016”.
4. Amendment No. 3 shall become valid and effective on the date it is issued.
