In Bratislava on January 26, 2021

Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as „STU“), based on Resolution of the Government of the Slovak Republic No. 30 from January 17, 2021, published in the Collection of Laws of the Slovak Republic under No. 8/2021 Coll. and Resolution of the Government of the Slovak Republic No. 44 from January 21, 2021, published in the Collection of Laws of the Slovak Republic under No. 14/2021 Coll., and Decree of the Public Health Authority of the Slovak Republic (hereinafter referred to as “PHA”), which decrees regulations regarding endangering public health during the regime of entry of persons into areas of service and areas of employment No. 14 from January 21, 2021, published in the Journal of the Government of the Slovak Republic section 8/2021, and in accordance with Article 5 (4) of Rector’s Order 2/2021-PR “Organisation of and conditions applicable to the educational process and operation of the Slovak University of Technology in Bratislava for the Summer term of the academic year 2020/2021” from January 21, 2021 (hereinafter referred to as “Rector’s Order”)

**Amendment No. 1**

To Rector’s Order No. 2/2021-PR from January 21, 2021

**Organisation of and conditions applicable to  
the educational process and operation  
of the Slovak University of Technology in Bratislava  
for the Summer term of the academic year 2020/2021**  
(hereinafter referred to as „Amendment No. 1),

which amends the Rector’s Order as follows:

**Article I.**

1. In Article 3, point (1) shall be added, and reads as follows:  
„1) For the purpose of prevention of spread of COVID-19 in accommodation facilities of STU, this Article stipulates conditions of accommodation in accommodation facilities of STU, based on Resolutions of the Government, Decrees of PHA and other measures of relevant authorities.“.

Current points (1) to (4) shall be listed as (2) to (5).

2. In Article 3 (2), new points (3) and (4) shall be added, and read as follows:  
„3) In the cases that a person accommodated in an accommodation facility is not able to provide documents stated in (2) in the time period of January 27, 2021 to February 02, 2021, such person is obliged to adhere to the lockdown measures, which can be adhered to in the accommodation facility, following the conditions set in Resolutions of the Government and Decrees of the PHA.  
  
4) In the case that a person accommodated in the accommodation facility tests positive for COVID-19, the quarantine period can transpire in the accommodation facility, following measures of relevant authorities and instructions of general health practitioner, without the option to exit their room.“.

Current points (3) to (5) shall be listed as (4) to (7).

3. In Article 3 (6), a comma and the words „completion of quarantine in the accommodation facility“ shall be added after the word „conditions“.

#### **Article II.**

1. Other provisions of the Rector's Order remain unaffected.
2. Amendment No. 1 shall become valid on the day of its issuance.
