## **Anti-epidemic measures of the Slovak University of Technology in Bratislava in relation to currently valid measures of State institutions in SR**

With regard to the continuing unfavourable epidemiological situation in relation to the COVID-19 pandemic, based on the Resolution of the Government of the Slovak Republic No. 30 from January 17, 2021, published in the Collection of Laws of the Slovak Republic under No. 8/2021 Coll. and Resolution of the Government of the Slovak Republic No. 44 from January 21, 2021, published in the Collection of Laws of the Slovak Republic under No. 14/2021 Coll., and in Accordance with Art. 4 (4) of the Rector's Order 1/2021-PR "Anti-epidemic measures of the Slovak University of Technology in Bratislava in relation to currently valid measures of State institutions in SR" from January 2, 2021 (hereinafter referred to as "Rector's Order"), the Rector

Anti-epidemic measures of the Slovak University of Technology in

(hereinafter referred to as "Amendment No. 1),

which amends the Rector's Order as follows:

**Article I.**

1. In the entire text of the Rector's Order, the date "24.01.2021" shall be replaced with the date "07.02.2021".
2. In Article 1 (2), the words: "and Amendment No.2 from January 13, 2021" shall be added at the end.
3. In Article 2 (1) (b), the words "responsible for execution of the present Rector's order" are removed.

4. In Article 2, (3) shall be added after (2), and states as follows:  
“3) Employees according to (2) of this Article which enter the workplace from January 27, 2021 to February 02, 2021, must show the following:
  - a) a negative RT-PCR test result performed from January 18, 2021, or
  - b) a negative antigen test result certified in the territory of the European Union for COVID-19, performed from January 18, 2021
  - c) proof of overcoming COVID-19 no older than three months.”

(3) shall now be referred to as (4).
5. In Article 3 (1), the word “and” after “districts” shall be removed.
6. In Article 3 (2), the word “Resolution” shall be replaced by “Resolutions”.
7. Article 3 (3) shall read as follows:  
„3) The provisions of the present article shall not apply to:
  - a) employees of STU staying at accommodation facilities,
  - b) members of collective authorities of STU staying at accommodation facilities,
  - c) guests staying at accommodation facilities at January 01, 2021.“.

## Article II.

1. Other provisions of the Rector’s Order remain unaffected.
2. Amendment No. 1 shall become valid on the day of its issuance.
