QUALITY POLICY of the Slovak University of Technology in Bratislava

Being aware of its mission to educate and raise the young generation in the spirit of the principles of humanism and humanity, to acquire, apply and spread new knowledge through scientific research, engineering and other creative activities, with the aim of meeting the strategic goals defined in STU's long-term plan for educational, scientific and research, artistic, development and other creative activities, and in an effort to set an internal quality management system enabling its continuous improvement, the Slovak University of Technology in Bratislava (hereinafter referred to as "STU" or "University") is declaring the present STU Quality Policy:

- Provide high-quality and broadly accessible university education meeting top international standards in engineering technical disciplines and related areas of natural and social sciences, built on active involvement of students in scientific research, art and/or other creative engineering activities, focused on the needs of economic and social practice, and improve it constantly;
- 2. Continuously contribute to increasing the level of education of society and the qualification prerequisites of employees by uninterrupted interest in lifelong learning;
- 3. Use its own creative activities to contribute to global scientific knowledge, to the development of engineering skills and artistic and aesthetic values in the young generation;
- 4. Constantly increase the positive impact of the University on society by continuously enhancing the quality of services provided in educational and scientific and research activities, and by transferring the results of the University's research and know-how to the business environment;
- 5. Build an atmosphere of academic partnership, esteem and respect among all stakeholders, employees, students, graduates, employers and other interest groups in an environment supporting professional growth and focus on internationally acceptable results;
- 6. Ensure efficient and transparent resource management, activate and optimize the use of existing financial resources and use long-term planning to ensure the economic stability and sustainability of the University's long-term development;
- 7. Continuously modernize and direct the spatial arrangement of the University so that its development creates an internationally competitive background stimulating cooperation among students, employees and partners.
- 8. Ensure and constantly perform modern University management, responsible control at all levels and generation of creative conditions for both students and employees in the form of gradual enhancement of the quality of internal processes and services.

All parts of STU shall implement and respect the STU Quality Policy. All University staff shall contribute to its implementation, thus becoming jointly responsible for continuous improvement of their own involvement as well as of involvement of the entire University.

STU's Quality Policy is reflected in practice through a quality management system coordinated by the Internal STU Quality System Board.

The STU Quality Policy Internal Regulation was commented on by the Academic Senate of STU on March 1, 2021 and approved by the Scientific Board of STU on March 15, 2021.



The STU Quality Policy Internal Regulation became valid on the date it was approved by the Scientific Board of STU and it shall come into effect on April 1, 2021.
