## Electronic information resources, citation, DOI

- Scholarly and scientific literature in electronic form on Internet
- Articles in journals, proceedings, dissertations, monographs...

## Electronic information resources, citation, DOI

According to the content:

- **Fulltext** – databases with fulltexts documents (ScienceDirect, SpringerLink).
- **Bibliographic** – bibliographic information of documents – authors, title, source, publication year, abstract (Scopus, Web of Science Core Collection).
- **Bibliometric** – tools for evaluating publications, researchers, institutions etc. (InCites)

## Electronic information resources, citation, DOI

According to the thematic focus:

- **Multidisciplinary** – databases cover more researcher areas (ScienceDirect, Wiley Online Library).
- **Monothematic** – databases cover specific area – technics, social sciences, humanities... ( IEEE Xplore, APS Physics, Detail Inspiration).

## **Electronic information resources, citation, DOI**

According to access for users:

- **Free sources** – libraries catalogues, law documents
- **Open access** – free of charges = with open access (OA journals, monographs).
- **Electronic information resources with license** – access possible through paid licence (by university, faculty...).

## **Electronic information resources, citation, DOI**

Field for publishing:

- Journal CCC (currented), indexed, impacted
- Web of Science/JCR (Journal Citation Reports): Impact factor, quartil
- Scopus/Scimago: SJR, quartil

## Electronic information resources, citation, DOI

**CCC journal** – journal from the database CCC (Current Contents Connect).

**Indexed journal** – journal from the database Web of Science Core Collection or Scopus.

**Impacted journal** – journal with impact factor (metric from Journal Citation Reports)

## Electronic information resources, **citation**, DOI

Why we need to cite?

- Copyright law
- Ethics

A citation is a reference to **the source of information used in your research (article, dissertation...).**

- Web of Science Researcher ID
- Orcid (orcid.org)
- ScopusID

## Electronic information resources, **citation**, DOI

**Quote** - words from a text or speech written or spoken by another person.

**Paraphrase** - expression the meaning of (something written or spoken) using different words.

**Citation** - An in-text citation is a brief notation within the text of your paper or presentation which refers the reader to a fuller notation, or end-of-paper citation, that provides all necessary details about that source of information.

**References** – the list of literature (information sources), which was cited in the text.

**Citation system** – the way how we connect in-text citation with reference at the end of the work.  
(Name and date system, numeric system, system of running notes)

Citation manager allows to:

- ▶ Format bibliography in ISO 690 and other citation styles
- ▶ Integrate citations and build references
- ▶ Import citations from others databases and sources
- ▶ Collect and organize citations in folders
- ▶ Share with other users
- ▶ **CitacePro**, EndNote, Refworks...

Available at Slovak University of Technology from 2020.

## Electronic information resources, **citation**, DOI

- Journals have their own references and citation style, which can be found in „Guide for authors“.
- Peer review – antiplagiarism softwares.



# Electronic information resources, citation, DOI

DOI = digital object identifier

- A DOI (Digital Object Identifier) is a unique and never-changing string assigned to [online](#) (journal) [articles](#), [books](#), and other works.

## Elektronické informačné zdroje, citovanie, **DOI**

Crossref was founded in 2000 by a group of publishers who needed an efficient method to connect their journal articles, and so began the use of DOIs to provide a way to link references between articles, making it easier for a reader to locate items that are cited. Using a DOI to identify content provides a unique and persistent link (= response page) that stays with the item even if its website changes. Response page contains bibliography record of the article (with pdf fulltext or linking to the fulltext...)

DOIs are assigned by the non-profit agency Crossref (or registration agencies authorized by it) on the basis of a closed membership between the agency and e.g. publishers, universities, etc.
