In accordance with Article 5 (1) of Rector's Directive No. 6/2015-SR Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize, the Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as "STU") is issuing the present

Amendment 2

to Rector's Directive No. 6/2015-SR of May 19, 2015 **Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize** (hereinafter referred to as "Amendment 2")

Article I

Rector's Directive No. 6/2015-SR of May 19, 2015 "Rules for awarding the Slovak University of Technology in Bratislava Rector's Prize" (hereinafter referred to as the "Rector's Directive") shall be amended and supplemented as follows:


- 1. In Article 1 (3) "university" shall be replaced with "STU", and "university" shall be inserted after "provides" throughout the entire text.
- 2. In Article 2 (1) "is awarded" shall be replaced with "may be awarded", "of the respective study programme" shall be inserted after "study", and "graduates in the respective program" shall be replaced with "graduates in the particular program".
- 3. In Article 2 (2) "is awarded" shall be replaced with "may be awarded", "of the respective study programme" shall be inserted after "study", and "graduates in the respective program" shall be replaced with "graduates in the particular program".
- 4. Article 2 (2) (c) shall read as follows:

"c) achieved also other outstanding results in professional activities in addition to the diploma thesis during his/her studies of the respective Engineer's or Master's program which the student may demonstrate with his/her name.".

5. Article 2 (3) shall read as follows:

"3. In noteworthy cases, the Rector may also award the STU Rector's Prize to graduates of a Bachelor's, Engineer's or Master's program for outstanding results achieved in professional activities during studies of the respective programme, where the student's GPA achieved was not worse than 1.5.".

6. Article 2 (4) shall be erased. The current paragraphs (5) and (6) shall be numbered (4) and (5).

"4. The Rector may award the STU Rector's Prize to a graduate from a doctoral program when the student achieved all of the following results during his/her studies of the respective doctoral programme:

- a) at least two outputs of creative activities of category A+ were published or demonstrably accepted in the field of habilitation and inauguration proceedings which were assigned to the field of study of the graduate's doctoral program. If more fields of habilitation or inauguration proceedings are assigned to the field of study, the field of habilitation or inauguration proceedings of the doctoral student's tutor shall be taken into consideration (hereinafter referred to as the "respective HaIP field");
- b) at least such total number of outputs of creative activities of category A+ or A in the respective HaIP field was published which is equal to the number of years of a standard term of study in the respective program;
- c) at least three lectures were presented personally in a foreign language at international conferences.".
- 8. In Article 2 (5) in the first sentence "5" shall be replaced with "4", and "to a graduate from a doctoral program" shall be inserted after "Prize".
- 9. In Article 3 (1) "university" shall be inserted after "provides".
- 10. In Article 3 (2) "and in the case of a graduate from an Engineer's, Master's or doctoral program, also documents or electronic links to documents proving compliance with the conditions for being awarded the STU Rector's Prize" shall be inserted after "behind it", and the following sentence shall be added at the end: "Documents or electronic links to documents proving compliance with the conditions for being awarded the STU Rector's Prize" shall be added at the end: "Documents or electronic links to prize as referred to in the first sentence shall be delivered by e-mail.".
- 11. In Article 4 (1) "STU" shall be inserted before "Rector's" and "diploma" shall be replaced with "bilingual diploma in the Slovak and English languages".
- 12. In Article 4 (2) "usually" shall be inserted after "is".
- 13. In Article 4 (3) "STU" shall be inserted before "Rector's".
- 14. The Annex to the Directive shall read as follows:
