In Bratislava on May 28, 2021 No. 5/2021 – PR

In accordance with Article 3 (1) (c) of Rector's Directive No. 4/2013 - SR "Rules for Issuing Internal Regulations of the Slovak University of Technology in Bratislava" of October 3, 2013, the Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as "STU")

#### is issuing

the following Rector's Order

### Admitting applicants to study programmes at the Slovak University of Technology in Bratislava in the academic year 2021/2022

laying down the following:

### Article 1 Recitals

- 1. The Rector's Order for admission of applicants to study programmes at the Slovak University of Technology in Bratislava in the academic year 2021/2022 (hereinafter referred to as the "Rector's Order") lays down the procedure to make sure that students admitted to study programmes of the first, second or third degrees may study the study programme to which they have been admitted in accordance with § 70 (1) (a) of Act No. 131/2002 Coll. on Higher Education Institutions, and on amendments and supplements to certain acts, as amended (hereinafter referred to as the "Act"), if STU is not going to continue with the study programme and plans to cancel it so that the students may continue with their studies of the study programme aligned with the standards for the study programme of the Slovak Accreditation Agency for Higher Education (hereinafter referred to as "Standards") in the same field of study in accordance with § 51a (2) of the Act.
- 2. For the purposes of this Rector's Order, STU faculty shall also be understood as a part of STU providing university education which is not a faculty.



#### Article 2

## Rules for admission to studies of study programmes of the first, second and third degrees at STU

1. The STU faculty shall admit applicants to study programmes of the first, second and third degrees in the academic year 2021/2022 which are aligned with the Standards or which the STU faculty plans to align with the Standards.

2. The STU faculty shall not admit any applicants to study programmes of the first, second or third degrees in the academic year 2021/2022 if it does not plan to align the study programmes with the Standards and plans to cancel them (hereinafter referred to as "Original Study Programmes").

3. The STU faculty shall enable applicants admitted to Original Study Programmes to enrol in the first year of study, if such applicants had been admitted before the present Rector's Order became effective. Then, at the start of the academic year 2021/2022, it shall enable students enrolled in the Original Study Programmes as referred to above to move to any study programme aligned with the Standards or which STU Faculty plans to align with the Standards in the same field of study or in a field of study which is one from a combination of two fields of study for which the Original Study Programmes are accredited.

4. The provisions of paragraphs (1) to (3) above shall not apply to applicants and students of Original Study Programmes which the STU faculty plans to replace with new study programmes, the accreditation of which it has requested from the Slovak Accreditation Agency for Higher Education (hereinafter referred to as the "Agency") before March 31, 2021 (hereinafter referred to as "New Study Programmes"), namely in the same field of study or in a field of study which is one from a combination of two fields of study for which the Original Study Programmes are accredited. The STU faculty may admit applicants to Original Study Programmes as referred to in the first sentence of the present paragraph and shall enable all admitted applicants to enrol in the Original Study



Programmes. Immediately upon accreditation of New Study Programmes the STU faculty shall enable students enrolled in the Original Study Programmes as referred to above to move to an accredited New Study Programme.

### Article 3 Final provisions

- 1. This Rector's Order has been issued with the intention of ensuring studies in study programmes aligned with the Standards.
- 2. In addition to STU employees specified herein, also other management staff at relevant management levels and all employees who are obliged to create all other necessary material, organisational, personnel and other conditions for performance of the obligations stated herein shall be liable for compliance with the present Rector's Order. The managerial staff are also responsible for making employees reporting to them familiar with the provisions of the present Rector's Order.
- 3. Persons responsible for compliance with the provisions hereof shall be authorized to specify details related to their performance.
- 4. This Rector's Order shall become valid on the date when it is issued and comes into effect on June 1, 2021.
