The Rector of the Slovak University of Technology in Bratislava (hereinafter referred to as "STU"), in accordance with Section 92, par. 15 of the Act No. 131/2002 Coll. on Universities and on Amendments and Supplements to Certain Acts, as amended, and in accordance with Article 9, Clause 2 of the Rector's Directive No. 11/2016-SR Tuition and Fees Associated with Studies at the Slovak University of Technology in Bratislava for the Academic Year 2017-2018 of 12 September 2016 as amended by Amendment No. 1 of 1 June 2017 issues this

 (hereinafter referred to as "Amendment No. 2")

### Article I.

Rector's Directive No. 11/2016-SR of 12 September 2016 Tuition and Fees Associated with Studies at the Slovak University of Technology in Bratislava for the Academic Year 2017-2018 as amended by Amendment No. 1 of 1 June 2017 (hereinafter referred to as "the Rector's Directive") shall be amended and supplemented as follows:

1. The words "*as amended*" are inserted after the words "*to Certain Acts*" in a footnote to reference No. 5.
2. The words "*in the wording of the Act No. 276/2017 Coll.*" are inserted after the words "*to Certain Acts*" in a footnote to reference No. 19, 19b and 20.
3. In Article 7 Clause 5 letter a) shall be as follows:  
*"a) the administrative fee for the recognition of documents on education for purposes other than the purpose of pursuing a regulated profession if the Slovak Republic **has concluded** an International Treaty on the Mutual Recognition of Equivalence of Educational Documents with the State in which the document was acquired<sup>19</sup> € 5".*
4. In Article 7 Clause 5, following the letter a), new etter b) shall be inserted:  
*"b) the administrative fee for the recognition of documents on education for purposes other than the purpose of pursuing a regulated profession if the Slovak Republic **does not have concluded** an International Treaty on the Mutual Recognition of Equivalence of Educational Documents with the State in which the document was acquired<sup>19</sup> € 30".*  
 Previous letters b) up to d) are referred to as letters c) up to e).
5. In Article 7 Clause 5 letter c) shall be as follows:  
*"c) the rate of the administrative fee for the recognition of the documents on education referred to in letters a) or b) of this Clause in the case of applications submitted by electronic means or through an integrated service point is 50% of the amount of this fee. If appendices are part of the application, the reduced rate of fees according to the first sentence shall apply only if these appendices are in electronic form<sup>19a)</sup>".*

6. A new Article 8a shall be inserted after Article 8 , which together with headings shall be as follows:

*“Article 8a*

***Transitory Provisions for Amendments Effective from 1 January 2018***

*(1) Procedures for the recognition of the documents on education that commenced before 1 January 2018 shall be completed according to the regulations in force until 31 December 2017.*

*(2) By issuing the Amendment No. 2 to this Directive, the fact is hereby declared that STU has proceeded in accordance with valid and enforceable legislation<sup>19</sup> in proceedings for the recognition of documents on education which commenced from 1 January 2018.”.*

**Article II.**

1. The other provisions of the Rector’ Directive shall remain unaffected.
2. Amendment No. 2 is an integral part of the Rector’s Directive.
3. Appendix No. 1 containing “The complete wording of the Rector’s Directive No. 11/2016-SR of 12 September 2016 Tuition and Fees Associated with Studies at the Slovak University of Technology in Bratislava for the Academic Year 2017-2018 as amended by the Amendment No. 1 of 1 June 2017 and Amendment No. 2 of 8 February 2018” forms an integral part of this Amendment No. 2 to the Rector’s Directive.
4. Amendment No. 2 to the Rector’s Directive shall enter into force as from the date of its issuance; this shall be without prejudice to Article 8a , Clause 2 of this Directive.
