

AGREEMENT ON COOPERATION

between

Kalashnikov Izhevsk State Technical University

Russia

and

Slovak University of Technology in Bratislava

Slovakia

In order to promote international cooperation and enhance education and research efficiency Kalashnikov Izhevsk State Technical University represented by its Acting Rector, Aleksandr Gubert, and Slovak University of Technology in Bratislava, represented by its Rector, Oliver Moravčík, agreed with following:

Article 1: Activities covered by the Agreement

1. Joint research and educational activities.
2. Visits and academic exchanges for research, teaching and staff development purposes.
3. Visits and exchanges of graduate and undergraduate students for study and research.
4. Exchanges of information in general, including exchanges of library materials and research publications.

Article 2: Research and educational activities

1. Partner Universities will implement and develop joint research and educational projects based on common interests.
2. Partner Universities will organise joint scientific and technical conferences, symposia, exhibitions and workshops.

Article 3: Academic exchanges

1. Partner Universities will exchange visits of members in charge of scientific and academic administration in the presidency of each University and their Faculties with the aim of exchanging information and expertise in the field of higher education management and research and to agree upon the conditions of joint research realisation.
2. Partner Universities will exchange visits of teaching staff to share expertise and research results as well as for lecturing and participating in conferences, symposia, seminars and other scientific events.

3. Partner Universities will exchange students of all academic levels for scientific qualification and training in addition to the participation in sport and cultural activities.

Article 4: Exchange of publications

1. Partner Universities will exchange literature, publications and periodicals issued by the other Partner University.
2. Partner Universities will exchange syllabi, curricula, regulations and systems related to scientific information of common interest.
3. Partner Universities will encourage publication of research and scientific papers issued by the other Partner University in periodicals and scientific reviews published by the other Partner University.

Article 5: Financial provisions

Signing of this Agreement does not commit any Partner University of any financial obligations. Each activity must be individually negotiated from the financial point of view.

Article 6: Validity and termination

1. This Agreement will come into force on the date of its signing by the Rectors of both Universities and will be valid for five (5) years.
2. Partner Universities may make amendments to this Agreement only upon mutual consent made in writing.
3. This Agreement can be cancelled with a written notice from one of Partner Universities submitted at least six months in advance of termination date.
4. This Agreement is written and signed in two original copies of equal validity in the English language.
