S T A T E M E N T

of briefing of students at the hostels of the STU about the fire prevention, safety and health protection instructions.

A. Safety and health protection region

1. Accommodation rules of the hostels of the STU and relative internal instruction

- I will not leave open appliances (electric, gas,...)without control in kitchens and I will keep restriction of using of electric appliances in hostels rooms (cells) in accordance with Accommodation rules
- I will keep cleanness and order
- I will conform to Accommodation rules of the hostels of the STU
- I will read fire prevention documentation which is on the bulletin boards in hostel corridors and I will conform to their instructions
- a will not impair fire facilities – manual fire-extinguishers, fire-mains, electronic fire
