## issues

## following instruction of director od the ASDaDH CONDITIONS OF PAYMENT AND ACCOMMODATION OF STUDENTS, ACCOMMODATED IN STUDENT DORMITORIES OF THE ADMINISTRATION OF STUDENT DORMITORIES AND DINING HALLS OF THE SLOVAK UNIVERSITY OF TECHNOLOGY IN BRATISLAVA FROM THE 1.APRIL 2021 (further only"Instruction").

In accordance with decision of government of the Slovak Republic No..160/2021 from the 17.03.2021 (further only "Decision of government") and subsequently with article 3, point 4) of Rector's direction **students** (PhD. students and foreign students including), who were not **to the 1.1.2021** in student dormitories of the ASDaDH, **can not come back** to the student dormitory of the ASDaDH (farther also "SD"), provisionally until **to the 28.04.2021**, i.e. **till the restriction of movement and residance by curfew** (further only "curfew").

Following the above:

1. Students, who **use** accommodation servises of given SD at present time and **to the 1.1.2021 were physically present** in SD, can still **stay in SD** subject to compliance with the conditions depending on the degree of warning in accordance with COVID AUTOMAT, with current decision of government of the SR and with Instructions of director of the ASDaDH about compliance with hygienic-epidemiological measures for accommodated persons from the 08.03.2021.

Student is obligated to pay price for accommodation in terms of valid Price list for every month of accommodation till the 5th day of given month at the latest.

2. Students, who **can not use** accommodation services of given SD at present time (they have signed accommodation contract or amendment No.1 to the accommodation contract and they have things in the room) **will not pay for accommodation from the 1.4.2021**, and that till the moment of possible return to SD.

3. Accommodation and check-out of students, resp. return of students to student dormitories (SD) will not be still possible , preliminary till the **28.04.2021**.

4. **Conditions** of **accommodation** again or of earlier **check-out** will be resulting from current valid decisions of government of the SR, from decrees of the Public Health Authority of the SR and from instructions of director of the ASDaDH of the STU and **will be published in advance** on web site stuba.sk.

5. Possible overpayment for accommodation at earlier **check-out of student** will be settled within **30 working days from the date of check-out at the latest.** 

6. If student did not pay for accommodation for the I. quarter 2021, or he/she has deficiency from the previous period, he/she **is obligated to pay the deficiency** in terms of valid Accommodation contract.

7. Provisions of Instruction of director of the ASDaDH 2/2021, which are not adjusted (changed) by this Instruction, are still valid..

8. This Instruction is valid from the **1.April 2021.**
