INSTRUCTION OF DIRECTOR OF THE STUDENT DORMIOTRIES

TO FULL-AREA TESTING FOR ALL ACCOMMODATED PERSONS IN STUDENTS DORMITORIES OF STU IN BRATISLAVA

To prevent the spread of transmitted diseases in accommodation facilities of the Slovak University of Technolohy in Bratislava (further only SD) and in accordance with current measures of the Public Health Authority of the Slovak Republic, I issue the following Instruction of director of Student Dormitories to full-area testing for all accommodated persons in SD of the STU in Bratislava.

- 1. Director of Student Dormitories **recommends** to all accommodated persons to take part in all-area testing.
- 2. All-area testing will be realized **from 31.10.2020 till 1.11.2020** and the second testing will be **from 7.11.2020 till 8.11.2020**.

Accommodated persons can be tested on any extractions site in Bratislava.

4. In case that you **do not take part** in testing and you do not have confirmation of negative result RT-PCR test made from the 29th October 2020 till the 1st November 2020, **movement restriction** will be applied to you in terms of resolution of the Government of the Slovak Republic No.693/2020 from the 28th October 2020 (further only "resolution") https://korona.gov.sk/wp-content/uploads/2020/10/zaka-vychadzania-2.11.-693 2020.pdf

Within in exceptions, stated in resolution, in needfull extent, you can go:

- to shopp a foodstuff, medicine and medical means, hygienic and drugstore goods,
- to medical facility for the purpose of medical examination or preventive examination and back.
- to execution of RT-PCR COVID-19 test and back.
- 5. If you have **negative result** of test, you must, **at any time** on demand of stuff of appropriate SD or police (movement in exterior), prove by confirmation of negative result of RT-PCR test made from the 29th October 2020 till the 1st November 2020 or by COVID-19 certificate issued by the Ministry of Health of the Slovak Republic with negative result of antigen test certified within the territory of the European Union made from the 29th October 2020 till the 1st November 2020.
- 6. If you have **positive result** of test, regulations stated in Instruction of director of Student Dormitories apply to you:

If the person violates the regulations and does not prove by confirmation of negative result of RT-PCR test or COVID-19 certificate issued by the Ministry of Health of the Slovak Republic with negative result of antigen test certified within the territory of European Union, the fine in amount of 1650 eur will be awarded.
