The director of the Administration of Student Dormitories and Dining Halls of the STU in Bratislava (further only „ASDaDH“) because of worsening of the epidemic situation in the context of disease COVID-19 pandemic, of restriction of freedom of movement and of curfew based on the resolution of the Government of the Slovak Republic No. 695 from the 24th November 2021 published in the Codex of the Slovak Republic under number 428/2021 of the Codex (further only „resolution of the government“), based on the valid decree of the Public Health Authority of the Slovak Republic (further only „decree of the PHA“) and in the meaning of the article 4 point 4 of the Command of the rector No.13/2021 - AE „**Anti-epidemic measures of the Slovak University of Technology in Bratislava in context with currently valid „resolution of the government“**“ (further only „Command of the rector“)

1. **Restriction of freedom of movement and curfew** in the meaning of the Resolution of the government No.695 from the 24.11.2021 does not apply to the time **from 05.00 till 20.00 o'clock**. for the student's journey to the and from the university, specialized teaching equipments and **purpose equipments of the university**. It is possible to leave the student dormitory after 20.00 o'clock only because of journey to the medical facility for the purpose of providing urgent health care, journey to the pharmacy and **to other operation departments determined in the resolution of government and of the decree of the PHA**.
2. **Restriction** of receiving of any **visits**, accommodated persons **from other rooms of given SD including and to gather** in corridors and common spaces is still valid;
3. **To announce positivity or duty of quarantine** in SD **only** by e-mail or by phone.
