**GREEN PHASE - THE SD HAS NO SUSPECTED OR CONFIRMED COVID-19 CASE**

<b>SR Student</b>	Affidavit	- Obligation to follow <b>"MDH" (Mask, Distance, Hands):</b> - wear a face mask in the interior premises of the "SD and SDA" except for their room,	PROHIBITION OF VISITS in the SD, - restrict entry to the SD only to accommodated students, employees and tenants.  - Minimize travel from the SD home or elsewhere during the academic year.	- Contact their general practitioner by telephone, - Subsequently inform the SD by e-mail about the situation and further steps. - <b>The SD recommends</b> that students and roommates <b>leave the SD</b> without accommodation and the return of students to the SD will be possible depending on the situation. - If students do not leave the SD, students must <b>minimize movement in the SD.</b>
<b>Foreign student from a "SC" (safe country)</b>		- Maintain safe distance,		- must contact the doctor or the RPHA by phone - must subsequently inform the SD by e-mail about the situation
<b>Foreign student from a "RC" (risky country)</b>	Negative test for COVID-19, performed on the territory of the Slovak Republic	- Disinfect hands after arrival at and departure from the "SD and SDA".	- Adhere to the current guidelines of the SD, the CCS SR (Central Crisis Staff of Slovakia) and RPHA (Regional Public Health Authority).	- The <b>SD recommends</b> that the <b>student leave the SD</b> , or the <b>SD moves the foreign student to a designated isolation facility</b> in the SD.
<b>Employee with permanent residence in the SR and outside the SR</b>	Affidavit			- contact their general practitioner by telephone - inform the SD and <b>leave the SD</b>

**Basic rule:** Persons are accommodated **under standard conditions** and the SD will set aside isolation rooms for foreign students who have subjective symptoms, cannot go home, will not require hospitalization and will not be able to be transported to the home environment.

**Sanctions:** In the event that the accommodated persons do not comply with the epidemiological recommendations and guidelines of the SD and the RPHA SR, the **Operations Director has the right to cancel their accommodation in the SD** without appeal.

<b>Green phase measures and orange phase measures apply at the same time.</b>				
<b>Accommodated person:</b>	<b>Start of accommodation:</b>	<b>Upon entry to the SD:</b>	<b>Orders, prohibitions and guidelines:</b>	<b>In case of "SUSPICION" of COVID-19 during accommodation:</b>
<b>SR Student</b>	If the disease is suspected, stay in isolation at the place of permanent residence and accommodate only after its end and a negative PCR test result.	Obligation to follow "MDH":  - Wear a face mask in the interior premises of the "SD and SDA" except for their room	- Prohibition on going out during <b>compulsory home isolation</b>	- Contact their general practitioner by telephone, - Immediately inform the SD of the <b>confirmation of the suspicion</b> of COVID-19 and of further procedure - The SD will order <b>the obligatory home isolation of the whole room, or unit</b> (without transfer to isolation facility) until the time determined by the general practitioner or the RPHA
<b>Foreign student From a "SC"</b>	In case of suspicion of the disease, stay in isolation and begin accommodation in the SD only after its end and a negative PCR test result.	- Maintain safe distance  - Disinfect hands after arrival at and departure from the "SD and the SDA"		- Immediately contact the doctor or RPHA by phone - Immediately inform the SD of the confirmation of COVID and of further procedure - The SD will order <b>the obligatory home isolation of the whole room or unit in designated isolation facilities in the SD</b> until the time determined by the general practitioner or RPHA
<b>Foreign student from a "RC"</b>				- Compulsory home isolation outside the SD - Contact their general practitioner and SD in cooperation with RPHA
<b>Employee with permanent residence in the SR</b>	In case of suspicion of the disease, stay in isolation at the place of permanent residence and begin accommodation in the SD after its end and a negative PCR test result.			- Mandatory domestic isolation in the designated isolation facility in the SD - Contact their general practitioner and SD in cooperation with RPHA
<b>Employee outside the permanent residence of the SR</b>				

**Basic rule:** A person with a "SUSPICION" of COVID-19 can only be **identified** by the appropriate RPHA or the attending physician. Persons have compulsory home isolation and the SD will provide the necessary services (food, hygiene and health needs) for the isolated student in return for payment. The SD will increase the frequency of cleaning common areas and disinfecting common contact areas to **3 times a day**

**RED PHASE - THE SD HAS A CONFIRMED COVID-19 CASE**

The **green, orange and red** phase measures apply at the same time.

Accommodated person:	Start of accommodation:	Upon entry to the SD:	Orders, prohibitions and guidelines:	In case of "CONFIRMATION" of the COVID-19 during accommodation:
<b>SR Student</b>	- If the disease is confirmed during isolation, the possibility of isolation will be extended until the time determined by the RPHA or a doctor and accommodation will only be commenced after its completion and a negative PCR test result.	Obligation to follow "MDH":  - Wear a face mask in the interior premises of the "SD and SDA" except for their room  - Maintain safe distance  - Disinfect hands after arrival at and departure from the "SD and the SDA"	- Prohibition on going out during <b>mandatory home isolation</b>	- <b>Mandatory home isolation outside the accommodation of the SD</b> , until the time determined by the RPHA or the attending physician  - If the student is not be able to complete home isolation outside of the SD and there are free accommodation capacities, then <b>home isolation may be arranged in a designated isolation facility in the SD</b> , until the time determined by the RPHA or the attending physician  - If there <b>is not</b> enough capacity of designated isolation facilities in the SD, <b>the isolation of the whole room or accommodation unit will be ordered.</b>

<b>Employee with permanent residence in the SR</b>				- <b>Mandatory home isolation outside the accommodation of the SD</b> , until the time determined by the RPHA or the attending physician - Contact their general practitioner and SD by telephone - In case of a positive result of a <b>foreign employee</b> , transfer to a designated isolation facility in the SD
<b>Employee outside the permanent residence of the Slovak Republic</b>				

**Basic rule:** A person **with a "CONFIRMATION"** of COVID-19 can only be identified by the appropriate RPHA or the attending physician. Persons have mandatory home isolation and the SD will provide the necessary services (food, hygiene and health needs) for an isolated student who has remained in isolation in the SD in return for payment.

- If there **is not** enough capacity of designated isolation facilities in the SD, **the isolation of the whole room or the whole accommodation unit will be ordered.**

The SD will raise the level of disinfection of areas in which a person with the confirmed disease was present **in the last 48 hours** before starting the mandatory home isolation.

If the **red phase** lasts for more than a week, consult the RPHA on the **interruption of the operation of the SD and the interruption of student accommodation.**
